It is hereby notified for the general information of all concerned, that the Higher Secondary School Certificate Part-I & II (Annual-I) Examination, 2024 of the Board of Intermediate & Secondary Education, Bannu will commence from **Tuesday 23rd of May, 2024.** Admission fee for Regular and Private Candidates must be deposited (**Through computerized system generated challan only**) in any branch of National Bank of Pakistan Itemad, The Bank of Khyber (within the jurisdiction of BISE Bannu).

INSTRUCTIONS:

- 1. Online admission will be closed on 22-04-2024.
- 2. The hard copy of the admission forms along with fee receipt (system generated) must be submitted to examination section on same dates slab otherwise next fee dates slab will be automatically imposed.
- 3. All the Registered Government and Private Institutions (Male & Female) within jurisdiction of BISE Bannu are directed to use our Online Admission Module (OAM) on www.biseb.edu.pk or portal.biseb.edu.pk for admission of 11th and 12th Class students through specific login (User name and password) already in use for Online registration, and submit a hard copy of the system generated admission list duly signed and Stamped by the Head of Institution along with the original bank receipt within due date.
- 4. Private Students shall submit their Admission Forms through Online www.biseb.edu.pk further they must submit photocopy of last appeared examination Annual-I / Annual-II DMC, system generated original Bank receipt with the admission form in HSSC Section of BISE Bannu.
- 5. Those Regular Students who are promoted to Part-II, OR migrated from other Boards and passed Science Part-I in Annual-I 2022 and not appeared in HSSC Annual-I Examination, 2023 are eligible to apply for HSSC part II as a regular candidate in Annual-I Examination 2024.
- **6.** Private Roll Number Slips shall be available on BISE Bannu Website www.biseb.edu.pk. 15 days before the commencement of examination, duplicate Roll Number can receive from HSSC Section of BISE Bannu by showing genuine reasons.
- 7. Private candidates who had passed SSC/HSSC Part-I Examination from other Boards (wants migration) must submit their Original Migration Certificate, Verified SSC / Part-I DMC / CNIC, Form-B, with Computerized online Admission form for Annual-I Examination 2024.
- 8. The installation of CCTV Camera in examination Halls / Rooms and to link with BISE Bannu is mandatory for new as well as already existing examination centres.
- 9. Application for creation of examination centres can be submitted up to 14-03-2024 through HSSC section, after due date no such application will be entertained in any circumstances, the creation of centre is subject to feasibility/ and approval of the competent authority
- 10. Heads of institutions are directed to clear all kind of dues from their Regular students well before submitting of examination forms, any request regarding stoppage of Roll No Slips/DMC's etc, as outstanding dues against the candidate / institutions shall not be entertained by the board.
- 11. For constitution of center of examination, each Institution shall make available accommodation, furniture as may be required by the Board.
- 12. Result Gazette Book Rs.3000/- (on need basis).
