**MINUTES OF MEETING REGARDING SECURITY ARRANGEMENTS**  
**FOR FORTH COMING SSC EXAMINATION HELD ON WEDNESDAY**  
**4<sup>TH</sup> MARCH 2020 AT 1100 HOURS UNDER THE CHAIRMANSHIP OF**  
**COMMISSIONER BANNU DIVISION.**

A meeting on the subject held under the Chairmanship of Commissioner Bannu on Wednesday 4<sup>th</sup> March 2020 at 1100 Hours. Meeting started from recitation of Holy Quran. The Chair welcomed all the participants. List of participant is attached.

The meeting was conducted to address the apprehensions of BISE authorities as well as to provide conducive environment to BISE authorities and the students.

After a detailed discussion following decisions were concluded.

1. Section 144 CrPc will be imposed within 200 yard area surrounding Examination hall w.r.to conduct of imminent SSC Examination and there should not be any Photostat shops within 200 yards radius of the Exam Halls. There shall be complete ban on sale and purchase of pocket guides.
2. Police Security will be provided at the main gates of the examination centers, and no police personal is allowed to enter inside until and unless requested by the Superintendent concerned.
3. There shall be 3 focal persons from the Deputy Commissioner Offices as well as from Police Office.
4. Each Deputy Commissioner will nominate at least two Additional Assistant Commissioner to Monitor SSC examination in their respective district.
5. During Polio campaign there will be shortage of Police force, but minimum police force may be deployed at the main gates of Examination hall.
6. District Education Officer Bannu & Lakki Marwat will ensure installation of CCTV cameras and CDR especially at the entrance of Examination Hall.

7. During Monitoring/Inspection of examination Hall, if an Invigilator is found helping or providing cheating material to student, he will be removed at once from duty by Board authority concerned.
  8. Duty staff Invigilator/Supervisory staff may be accommodated near to Examination hall in North Waziristan Tribal District.
